每日行程安排

第 01 天: 聖地亞哥 San Diego 220 mi/3.5hr - 聖塔芭芭拉 Santa Barbara 55 mi/1hr - Atascadero

早上專車從**聖地亞哥**出發,一路北上沿途欣賞加州南部海岸風光。約3.5小時後抵達加州中部海岸的**聖塔芭芭拉**,遊覽這座充滿西班牙殖民地風情的城市,這裏有全美最漂亮的**法院**,整個建築被精緻的磁磚佈滿,既美麗又有特色。**鐘樓**是這裏的至高點,站到鐘樓上,視野遼闊,提供 360 度的視覺饗宴,市景、山景、海景,盡收眼底。橘瓦白牆真的是堪稱絕配,這個小鎮所有的公共建築都非常值得拍照留念。徒步慢慢逛有著古典西班牙式風格的建築市區,欣賞阿卡達商店街的特色商店和畫廊,也可以在附近餐廳或咖啡店欣賞街景和享受美食,享受置身歐洲街道的感覺。

傍晚抵達Atascadero這個安靜的內陸小鎮,您將在此入住1晚。

第 02 天: Atascadero (44mi/45min) - 赫氏古堡 Hearst Castle (136mi/2.5hr) – Tulare

早餐後,專車前往**赫氏古堡**,造型古典氣派,屹立人跡罕至的群山顛頂,赫氏古堡是當之無愧的世界上最豪華、最奢侈的古堡,由美國報業鉅子斥資千萬所修建的,歷時 28 年,耗費 1.65 億美元,整個建築有歐洲地中海風格,花園為意大利式和西班牙式,集自然美、建築美和藝術美(雕塑繪畫)於一體,整個莊園有 165 個房間。主樓內由電影院,圖書館,彈珠室、酒窖及貴賓房等。堡內珍藏價值連城的古董及藝術品,豪華鑲金的室內游泳池,令您歎為觀止。傍晚時分抵達 Tulare,晚餐後前往飯店休息,您將在 Tulare 休息 2 晚。

第 3 天: Tulare 83mi/1.5hr Sequoia 神木國家公園/國王峽谷公園 50mi/1hr Tulare

早餐後, **開啟全天國家公園之旅。**

驅車前往**紅杉木國家公園(Sequoia Canyon National Park)**,這個國家公園以其宏偉的美洲紅杉樹、高聳的山脈、深陷的峽谷、咆哮的河流而聞名。公園境內的**惠特尼山**是美國本土最高的山,海拔 14,494 英尺/ 4,417 米。紅杉國家公園因其巨大的美洲紅杉而聞名,紅杉林高達數十丈,非常壯觀。其中**謝爾曼將軍樹**可是紅杉公園內的必去景點,它是世界上最大的樹!這棵巨杉的總重量接近 2,000 噸,高 83.8 公尺,底部最大直徑達 11.1 公尺。這顆巨杉樹齡約為 2300-2700 年,並還在不斷增寬中!如果





用它的樹幹裝滿水，供一個人每天洗一次澡，可用 27 年！位於國王峽谷格蘭特林場 (Grant Grove) 的格蘭特將軍樹是世界上第二大的紅杉樹。進入原始的山林中，靜看山間的湖水，聆聽大自然的聲音。美景令人心曠神怡。接下來前往紅杉公園的最佳瞭望點 **Moro Rock**，從停車場到峰頂的步道約 350 級台階，大約需要半小時，峰頂海拔 2,000 米左右。從山頂望去，之前需要抬頭仰望的高大樹木如今可以從上到下俯視，你可以盡情縱覽原始紅杉森林，遠眺美國本土最高峰--惠特尼峰(Mount Whitney)，還能看到群峰山頂尚未融化的積雪。行程結束返回酒店休息。

2026 美國聖地亞哥觀光一日遊

出發日期：07/13/2026 週一

早上 9AM 從酒店出發展開精彩的一日遊。

首先前往位於海灣岸邊的 **Seaport Village (海港村)**，這裡有幾十家酒店、酒吧、咖啡廳和禮品店，空地上綠樹成蔭海鷗成群，令人目不暇接，是遊客和當地人都喜歡的休閒散步之所。搭乘遊船遊覽海濱風光，近距離地觀看美國海軍服役中的航空母艦，遠觀雄偉壯觀的 Coronado Bridge 跨海大橋，更能看到一群可愛的海獅慵懶地趴在岩石上，享受日光浴。登上停泊在港口的**中途島號航空母艦**--曾是美國海軍的一個標誌，是美國海軍中途島級航空母艦的首艦。於 1943 年建造，直到 1997 年正式退役，整整 42 年的軍旅生涯共參與第二次世界大戰，越南戰爭，以及 90 年代的沙漠風暴行動等多項軍事活動。遊客可登船參觀艦橋，飛行甲板，飛機庫，航空交通管制台，戰略指揮中心，機房，官兵宿舍，海軍司令和艦長的寢室等各種設施。



接下來前往**聖地亞哥老城**，一個美麗而充滿樂趣的歷史古城，它是加州的誕生地，也是西班牙早期殖民地，同時也是第一批歐洲人定居所。這裡有 150 多家商店，有屢獲殊榮的餐廳，17 個博物館和歷史遺跡。參觀體驗加州早期西班牙式建築物和歷史文化。



最後前往**巴爾波公園**--美國最大城市文化公園；於 1910 年建成，園區共有十四座頂級博物館、四個劇院、複合式運動場、玫瑰園等，為巴柏雅增添絢麗的色彩。現今公園內許多華麗的建築，均是 1915 年「巴拿馬加州博覽會」舉行時所留下的偉大遺產，繁複的城堡建築不僅反映當時盛行的西班牙殖民文藝復興時期的



特色，同時也流露出濃厚的哥德、巴洛克與洛可可風。園內的「加州塔」高達兩百呎，內懸一百個小吊鐘，每十五分鐘百鐘齊鳴，有如天籟之音。自然史博物館中的肉食性恐龍化石，巨型屏幕影片，西班牙村莊藝術中心中超過 50 位藝術家的繪畫、雕塑、攝影、首飾、木雕、玻璃吹和瓦器等都只不過是巴柏雅城市公園的冰山一角。這絕對是一個值得讓您深度歷險，一探究竟的好地方。

傍晚帶著滿滿的回憶於 6:30PM 抵達酒店，結束這浪漫休閒的一天。

State of California

Release and Waiver of Liability, Assumption of Risk, Indemnity, and Media Release Agreement

1. Release of Liability
